#### 1. OPENING

The meeting was called to order at 7:05 p.m. with prayer and devotional by Canon Stephen. Nancy welcomed all present and asked each member to introduce themselves.

The prayer and devotion will be led by Rebecca at the next Advisory Board meeting.

# 2. APPROVAL OF AGENDA

On a motion duly moved, seconded and carried, the agenda of the meeting held on April 20, 2021 was approved.

#### 3. OTHER BUSINESS

#### **CONFIRMATION OF MINUTES**

The Board reviewed the minutes of the Advisory Board meeting held on March 16, 2021 and noted the following amendments:

- Church Wardens' Report: Rejuvenation Project Replace "Rejuvenation project" with "Re-opening protocols".
- Committees & Ministry Areas: Anglican Church Women Insert "Anglican Church" and "as the speaker". Delete "is expected to be in attendance", should read "...Anglican Church Women's service ... as the speaker."

On a motion duly moved, seconded and carried, the minutes of the meeting held on March 16, 2021 was confirmed, as amended.

#### **MATTERS ARISING**

There were no matters arising from the previous minutes.

#### **CHURCH WARDENS' REPORT**

Ed gave a brief presentation of the Church Wardens' report and highlighted the following items:

• Unaudited Financial Statements: Ed gave a brief report of the unaudited financial statements for the period ending March 31, 2021. The Corporation recorded a surplus of \$9,000. He noted that the revenue reflected a balance of \$98,000 and expenses recorded a balance of \$132,000 which resulted in a deficit of \$34,000.

- Lawn maintenance: A new landscaping contractor has been retained.
- Interment Fees: The Wardens have approved the new interment fees.
- Annual Parochial Returns: The annual parochial returns were submitted to the Diocesan office.
- **Cemetery Committee:** The annual spring cemetery clean-up has been postponed due to the COVID-19 stay at home order.
- **Rejuvenation Project:** The first set of conversations have been completed, it was noted that the discussions were good and engaging. It was noted that there was space available in the two Tuesday groups. Ed noted that the second set of conversations were scheduled to commence the first week of May, 2021.
- Vestry Approval of the Audited Financial Statements: Ed thanked everyone for their participation at Vestry on April 18, 2021 and noted that the audited financial statements for the year ended December 31, 2020 were approved. He further noted that an explanation of the auditor's opinion will be included in the mid-term report.
- Parish Leadership Training: The parish leadership training has been scheduled for April 29, 2021. Canon Stephen encouraged all Advisory Board members to attend.

#### **INCUMBENT'S REPORT**

An update of Incumbent's Report was presented by Canon Stephen. The following items were highlighted:

- **COVID-19 Restrictions:** HTC's COVID-19 protocols/plans have been submitted to the Diocese
- **Leadership Workshop:** The date for the annual leadership workshop for our episcopal area will be held on April 29, 2021.
- Episcopal Leadership Working Group Report/Town Hall Meeting: Canon Stephen encouraged all to watch the video and to join one of the four townhall meetings.
- Course on Transformational Leadership: Canon Stephen noted that he has been invited to lead an online course on Transformational Leadership for clergy as part of their continuing education program. The course commences April 28, 2021 for a period of five weeks.

Linda Robertson gave a brief update of the ACW noting that they were looking at the following fundraisers:

a) WiFi/Online Learning: Rebecca suggested that HTC should reach out to the schools in the parish to identify if there are children who require stronger WiFi and/or access to online learning. She further suggested that the auditorium could be used.

- b) **Eva Rae Bursaries:** It was noted that the Wardens will open the applications for the Eva Rae bursaries.
- c) **Re-imagine Discussions:** It was further noted that the re-imagine discussions/seminars will be held late May, early June.

**FEBRUARY 28, 2021** 

The Meeting was held using ZOOM because of the "lockdown" imposed because of the COVID-19 outbreak. Only 4 parishioners were in the auditorium. Edward Carter, Peter Paterson, Brother Reginald Crenshaw and Canon Stephen Fields. The Reverend Canon Stephen Fields chaired the meeting. 75 persons registered to attend via ZOOM. There were 67 members present on zoom.

# 1. Opening Prayer: Canon Stephen

The meeting opened at 10:34am with a welcome and prayer.

The parishioners were informed that the session was being recorded.

#### 2. Appointment of Vestry Clerk

On a motion by Pat Merchant and seconded by Maurice Corbett, Sharon McNelles was appointed as Vestry Clerk.

#### 3. Agenda

Nancy Cutler informed the meeting that the 2020 Audited Statements were not ready for the meeting. Canon Stephen and the Wardens informed the Diocesan Bishop and discussed the options with him. He approved the decision that rest of the business of Vestry should be addressed and that Vestry be reconvened at a later date to receive the statements when they were ready for presentation.

On a motion by Linda Robertson and seconded by Ron Tolhurst, the Agenda was approved.

# 4. Adoption of Minutes

#### 6. Looking to the Future

# 6.1 **Presentation of the Budgets** by Edward Carter

# i. Operating Budget:

The property income has been severely impacted by COVID-19. The CERB for wage subsidy from the Federal government and the Jubilee from the Diocese were a great help. The financial statements will show a surplus of about \$70K

The projected income for 2021 was estimated at \$443,580 with a projected expenditure of \$510,000. The deficit will be funded by the 2020 surplus and the General Ministry Fund.

On a motion by Edward Carter and seconded Nancy Cutler, Vestry approved the 2021 Operating Budget as recommended by the Wardens for our ministry.

*ii. Capital Expenditure Budget:* The projected capital expenditure for 2021, estimated at \$24,450, will be funded from the Capital Reserve.

On a motion by Edward Carter and seconded by Ron Tolhurst, Vestry approved the 2021 Capital Expenditure Budget

Canon Stephen thanked the Wardens, the Finance Committee and Property Committee for all their work during the past year

#### 6:2 Social Justice: Committing Ourselves to Anti-Racism

The motion was proposed by Robin Pacific and seconded by Bari-Lynn Butters. Robin introduced the Social Justice motion. She said that racism is in every level of society and there needs to be a collective will to end it. She spoke about the motion which joins our parish with the rest of our church, National and Diocesan, and undertakes to do the following:

- 1. Pray, deliberately, in all aspects of our life at Holy Trinity, recognizing that we cannot fix things with our own power but need first to come to the Source of all Life and Truth, to be refreshed, strengthened and, in the power of the Spirit, be led forward with the hope of realizing God's dream of fullness of life for all God's people.
- 2. Support our church's Rejuvenation Project, already begun, to enable our members to work towards fulfilling their dream of what their future church will be, recognizing that this will require honest and open conversations on this and other subjects.
- 3. Support the anti-racism and anti-bias training initiatives and projects of our Diocese and National Church, and encourage our members to participate in them.
- 4. Support training and educational opportunities provided for our parish leaders, staff, and members to equip them to be able to recognize racism and bias, and work to dismantle these pernicious evils wherever they may be present in our society.

There was a concern about the word "Black" and that the issue should include all "all forms of racism". It was pointed out that all forms of racism have been identified in the motion and the conversations across the diocesan and national church. However, at this point the spotlight is on anti-Black-Racism.

When put to the vote the motion was CARRIED.

- 11.2 Canon Stephen said the opening prayer. He acknowledged the 61<sup>st</sup> wedding anniversary of Gail and Darryl Thompson and said a prayer to mark the occasion.
- 11.3 Lay Alternate Member: On a motion by Barry Pipes and seconded by Sharon McNelles, Edmund Baumann was elected to serve as the Lay Alternate Member for Synod.

#### 11.4 Presentation of Audited Statements

- *i.* Edward Carter announced that a bookkeeper was hired in March to assist the wardens and treasurer. Bank reconciliations will be done monthly and will more quickly reflect the month to month financial operations of the church.
- *ii.* He then presented the audited statements for the year ending December 31, 2020. He pointed out that the cash available included partners' funds on deposit for Refugee Sponsorships.
- *iii.* Pat Burton expressed concern about the words "Qualified Opinion" in the Auditor's report. It was pointed out that these words have been in previous reports. Further, the auditor could not verify cash received. This is explained in the preceding paragraph, "Basis for Qualified Opinion".
- *iv.* Gloria Downey asked that the money paid to Credence & Company should be detailed in the notes to the statement. It was pointed out that, as is standard practice, these fees are included with other payments to other companies
- **v.** On a motion by Edward Carter and seconded by Nancy Cutler, the audited statements were received.

#### 11.5 Appointment of the Auditors for 2021

On a motion by Edward Carter and seconded by Nancy Cutler, Booth & Partners CPA Professional Corporation were appointed auditors for the year 2021.

Canon Stephen thanked the wardens and members of the fianance committee for their diligence and commitment.

#### **Incumbent's Report**

#### ST. STEPHEN'S, MAPLE

Alleluia! Christ is risen!

Fr. Stephen, as we discussed, St. Stephen's Maple could benefit from a more collaborative relationship with Holy Trinity, Thornhill.

St, Stephen's Maple, a missional Church plant, of the Diocese of Toronto, is today, a community of approximately 24 families, including about 7 children and 6 teens. Diocesan Council, approved its transition to a Canon 25, mission effective March 1<sup>st</sup>, 2021.

The Rev'd Jeff Potter, who relaunched the community, was Assistant Curate at Holy Trinity Thornhill and HTC's Enid Corbett serves as Administrator for financial operations.

I happily assumed, as we considered, what was then Bishop Peter's invitation, to St. Stephen's, Maple, that there was an ongoing relationship with HTC, and other neighbouring parishes. To my mind, St. Stephen's needs this kind of support as there is much work to be done in order to stabilize and transition this reboot from Diocesan Mission to self sustaining parish.

I am first, kindly asking you, and the Wardens of Holy Trinity, Thornhill to consider, engaging with St. Stephens's Maple as a collaborative partner to help us journey through this transition.

Secondly, I am asking you to propose a candidate, to serve for one year on the Board of Management. Thank you for your kind consideration of this request.
